Notes of the **Committee Meeting** at 27 Roman Way **Wednesday 4th October 2017 – 7.30pm**

1. Apologies

2. Minutes of the last meeting on 26th July and matters arising

The minutes were agreed as a true record of the last meeting.

Paul referred to the minutes of the Strengthening Local Relationships meeting where the UTC meet with ESCC to discuss local issues.

Speeding and the possibility of a 20mph speed limit in Browns Lane was discussed and Paul is seeking data from a previous monitoring exercise. It will cost £400 to undertake the necessary speed checks to make a case and Paul has offered a contribution from the Association's funds.

The speed indicator device (SID) is to be used at hot spots in the town including Browns Lane.

At the same meeting, it was reported that two applications for the Manor Primary school crossing patrol had been made but then withdrawn and that the school had said that it no longer needs a patrol. Note, as the school does not meet the ESCC criteria it would have had to sponsor the patrol.

3. Treasurer's Report

Sally circulated her report and advised that the Association has a current bank balance of \pounds 1,210 of which \pounds 484 is earmarked for the Walk and Talk campaign and \pounds 350 for next year's Big Lunch (grant from Awards for All).

Peter advised the £350 of the Walk and Talk fund was earmarked for a UCTC competition – to make a road safety video for YouTube.

The Surgery Car Service is £19 in surplus.

4. Secretary's Report

Peter reported as follows:

- Membership 146
- Social media activity now 454 people following our Facebook page and 268 following our Twitter feed.
- Correspondence
 - A Certificate of Appreciation has been received from the Kent Surrey and Sussex Air Ambulance charity for the £156.56 raised by the Association.

5. Walk and Talk campaign

Peter and Paul met with County Councillor Claire Dowling to explore how parking around the schools might be addressed following the County Council's responses to the initiatives that had been proposed. Cllr. Dowling will be liaising with ESCC officers and the matter will be included in discussions at the forthcoming meeting with Sussex Police which Paul and Peter will be attending.

6. Anti-social behaviour meeting (with Sussex Police)

As referred to in the previous item.

Peter advised that a resident that lives opposite Manor primary and who uses a mobility scooter had submitted an enlightening account of her experiences and difficulties.

This account will be used at the meeting and Ric and Andy offered to provide Peter with photographic evidence.

It was reported that school staff park in the road adding to the congestion.

7. Grant applications

- application to the Town Council for a handrail to serve the steep path at Browns Lane shops unsuccessful
- application to the Big Lottery (Awards for All) for the Big Lunch 2018 successful (£350)

8. Surgery Car Service (SCS)

Sally reported that 137 journeys had been undertaken so far this year, which already exceeds the total for the whole of last year. Alan and Gill were mentioned as providing the bulk of the service for which the committee thanked them.

Sally has been approached by Cllr Barry Marlow who enquired whether the Association wished to be included on the <u>access2healthcare.org</u> webpage.

Peter said that Church Coombe Community Association were not proceeding with the plan to join the Surgery Car Service at this time but will review their position in the new year.

9. Woodland Trust

The Woodland Trust offer to provide trees and shrubs for schools and community groups to plant was discussed but no suitable site which belonged to the community could be identified (minimum size of a tennis court).
